



분리 계약

SEPARATION AGREEMENT

Hadrian Seung hereinafter referred to as "Hadrian" and Michelle Seung, hereinafter referred to as "Michelle" hereby agree to the following:

A. Preliminary Matters

1. Hadrian and Michelle were lawfully married on 8th of March, 1996, at Uijeongbu District Court, Goyang, in the Republic of South Korea. Because certain problems have developed between "Hadrian" and "Michelle", they hereby agree to live separately and apart, subject to the terms and conditions as set forth below.
2. Hadrian and Michelle have made a complete, fair, and accurate disclosure to each other of all financial matters affecting this agreement.
3. Hadrian and Michelle have each been advised and counseled by attorneys of their choosing regarding their legal rights as related to this agreement.
4. This agreement is intended to be a final disposition of the matters addressed herein and may be used as evidence and incorporated into a final decree of divorce or dissolution.
5. Should a dispute arise regarding the enforcement of this agreement, the prevailing party will be entitled to his or her reasonable costs and attorney's fees.

B. Custody and Visitation

The children of this marriage are:

Choo Seung	May 12, 1997
Hinn Seung	June 04, 1999
Cha-sa Seung	July 01, 2002
Jung Seung	September 08, 2004

Legal Custody of the above-named minor children is awarded to Michelle.

C. Family Support. The parties acknowledge the service member's obligation to provide adequate financial support (referred to as "family support") of a spouse, child, or other dependent for which the member receives additional allowances for support.

Payment of family support is as follows:

- (1) Hadrian agrees to make a onetime cash payment of \$781,750.00 as Family Support to the Michelle
 - **Child Support**
\$356,000.00 of Family Support agreed to herein above is designated as child support.
 - **Spousal Support**
\$255,000.00 of Family Support agreed to herein above is designated as spousal support.
 - **Medical Support**
\$170,750.00 of Family Support agreed to herein above is designated as medical support.
- (2) That Hadrian Seung has paid the sum of \$195,000.00 to Michelle Seung from the total amount of \$781,750.00 on this day December 22nd, 2011 on account of the family support.
- (3) That Hadrian Seung is to pay the remaining balance of \$586,750.00 on or before March 2012.
- (4) All such payments will be made by either a Certified or Cashier's check payable to Michelle Seung or any individual/person/attorney as required by Michelle Seung.
- (5) If any such payment is not made on time, Michelle shall be entitled to declare to Hadrian that the entire entitlement is due and payable, and to immediately enter judgment against Hadrian for the unpaid amount and the entitlement plus accrued interest in any court having jurisdiction.

H. Other

Any issues not addressed in this Agreement shall be reserved for a court of competent jurisdiction.

This Agreement shall be deemed null and void in its entirety if (1) both parties revoke the Agreement in writing, (2) the parties reconcile and resume living together, or (3) the Agreement is superseded in its entirety by a court order. Any terms of this Agreement not superseded by a court order shall remain valid and in effect
